- 4. After fully charging (normally 24 hours), unplug the lamp from the wall.
- 5. Push down on the rubber insulated switch. The lamp will light and the GREEN LIGHT on the lamp will come on.

**CAUTION!!!** The CON-TROL-CURE® Short Wave Ultraviolet Lamp emits 254nm UV, which can cause severe irritation or burning to unprotected eyes and skin. Wear UV blocking eyewear when in use to avoid injury.

Both the UV Light-365 Long Wave Ultraviolet Lamp and UV Light-254 Short Wave Ultraviolet Lamp can operate as A/C lamps by purchasing external plug-in AC/DC adapters from UV Process Supply, Inc.

Simply plug this ballast into the connection located above the GREEN light and turn the lamp on. The GREEN light should come on indicating the lamp is operational.
