

Cleaning and General Care Instructions for CON-TROL-CURE® UV Blocking Window Films:

Although softer than glass, our window films are a durable product and will retain their UV blocking characteristics and appearance for a long service life. Because they are a polyester plastic material, these general special care instructions are being provided as a guide toward maintaining their appearance and intended functionality.

If you notice some changes in appearance over the first 2 weeks, this is normal, as it is simply the natural drying/bonding process occurring.

Please Note:

- 1. Do not clean the UV window film during the drying period. Since there is additional moisture absorbed into the film during application, it is slightly softer at this time and could be scratched easier. Also, by adding cleaning agents to the surface before it has properly dried, you are prolonging the drying period and could harm overall adhesion over the long term.
- 2. A slight hazy or blurry appearance may be noticeable after initial installation. As the film continues to dry, clarity will gradually return.
- 3. For ideal results, do not clean the film for 3 weeks after installation, preferably longer for interior windows not exposed to the sun.
 - a. **Definitely do not use**: brushes, harsh/coarse paper towel products, cleaners containing ammonia, industrial strength cleaners, or any solutions that contain abrasive/grit materials.
 - b. **Always use** a soft clean cloth to wash and dry your windows. Regular non-ammonia **Windex or* other similar window cleaning solutions may be used. A soft rubber squeegee may also be used.
